### **NEW! Online Member Application**

Cloud AMS's new interactive membership application will significantly improve the onboarding process for new applicants by collecting all required documentation and validating the prospective applicant's information in advance. Major features include:

- **Email Validation** – checks against existing database to eliminate duplicate applications
- **License Verification** – with your state's department of Real Estate\*
- **NRDS Verification** – through NAR's M1 interface
- **Document Uploads** – applicants upload important documents such as real estate license or letter of good standing, with options for requiring selected documents
- **Billing** – new functionality to display and collect dues, application fees, and charges for optional services
- **Automated Email Notifications** – sends email to pending applicants when application has been submitted and approved
