### The following enhancements have been implemented in version 2.2.04:

- Association ID' and 'Primary Indicator' Added to Phone Query Form
- Dues History Form Updates
- New Calendar Control for Date Selection

### **Expanded Options for Credit Card Management in AMS and IMS**

Cloud AMS now allows association staff to update Auto Payment options for credit cards that were entered in Internet Member Services (IMS) by association members. In the past, it was only possible for staff to modify these Auto Payment options for credit cards that were entered directly in AMS.

In addition, association members can now view all of their stored credit cards in IMS, including cards entered by staff in Cloud AMS that were previously unavailable in IMS. Note that with this change, it is now possible for members to modify or delete credit cards that were entered by association staff on their behalf.

### 'Association ID' and 'Primary Indicator' Added to Phone Query Form

The **Phone Query Form** has been updated to include the **Association ID** and **Primary Indicator** fields, allowing users to filter and export records using these fields.

# Rapattoni *Magic*-Cloud AMS Maintenance Report 2.2.04

This report is designed to inform Cloud AMS key contacts of software maintenance items. Please note that this report may not be a complete list and that items affecting only one Cloud AMS customer may not be included in this report.

### The following maintenance items have been implemented in version 2.2.04.

### Membership

The 'Office Name' column was not sorting properly on the Office Association Maintenance Form. This has been corrected so that the column sorts alphabetically as intended. (RNI 180813-000127)

When running a Billing Type Printout, the system was bypassing the print options and preview to send the report directly to the default printer, and the left side of the report was being cut off. These issues have been resolved so that content is no longer cut off and the report now leverages its Print Setup options properly, allowing user to select a printer, output to PDF, or adjust other options as needed. (RNI 181121-000017)

### Accounting

The Auto Apply Credits Utility was sending its report directly to the default printer even when the "Print To" option was set to PDF or the report was set to be converted to Excel or other formats. This has been fixed so that the report leverages Print Setup options as intended, opening as PDFs, Excel spreadsheets, and other formats as intended. (RNI 180817-000070)

In some instances, members who qualified for credit card auto-pay were not being processed due to an issue with their database records. This issue has been corrected and the underlying data has been repaired to ensure that all qualifying members are included in credit card auto-pay. (RNI 181127-000049 & 181031-000087)

The Member Credit Card Info form previously allowed users to leave "Allow Auto Payment" enabled when deleting the required Invoice Type and/or Sort Sequence values. The form's validation has been corrected so that the "Allow Auto Payment" option must be disabled before deleting Invoice Type or Sort Sequence. (RNI 181127-000048)

On the Credit Card Expiration Form, the system was erroneously allowing users to modify Auto Pay, Invoice Type, and Sort Sequence values that were intended to be unmodifiable on this form. This issue has been resolved so that Expiration Date is the only field that can be modified on the Credit Card Expiration Form. (RNI 181205-000052) Entering a credit card on the Member Credit Card Info form was setting Expiration Date to the first day of the specified month, while the credit card entry feature in Internet Member Services (IMS) would set Expiration Date to the last day of the month. This has been fixed in Cloud AMS so that the Member Credit Card Info form sets Expiration Date to the last day of the month, matching the logic in IMS as well as standard industry practices. (RNI 181128-000115)

Due to a change in the Group Detail Report files provided by NRDS, the NRDS Settlement Import utility was presenting a file format error message for valid import files. This has been fixed and files adhering to the updated NRDS format can now be imported without triggering errors. (RNI 181205-000014)

In some instances, the Sales Invoice Form was not showing the sixth line of text from the Default Invoice Message on the Sales Invoice Setup Form. This issue has been resolved so that all six lines of text display as intended. (RNI 180508-000125)

### Education

On the Class Information Form, the Range and Locate lookups for the 'Class ID' column were showing 'Event ID' as the field name. They now show 'Class ID' as the field name to match the column heading. (RNI 180521-000159)

The instructional text on the Recalculate Education Card Counts/Credits Utility was previously being cut off. This has been fixed so that the text displays in its entirety. (RNI 181204-000128)

### Inventory

The Inventory Adjustment Report was cutting off the last character in longer Charge Code values. This has been resolved and Charge Codes now display in their entirety. (RNI 140918-000121)
