

Subject: Rapattoni Magic 10.2.09 Special Update for Contribution Disclosure Compliance and New MasterCard Prefixes

Dear AMS Customer:

With dues season approaching for many boards, we've updated Rapattoni *Magic* 10 and IMS with a new field for displaying contribution disclosure text on invoices, plus an additional enhancement for processing new MasterCard prefixes.

Set Up Contribution Disclosure Text for PDF Invoices

The Invoice Type Table in Rapattoni *Magic* 10 has been updated with a new "Contribution Disclosure on Invoice" field for setting up custom disclosure text for PDF invoices. This new feature may be used to support Realtor Political Action Committee (RPAC) disclosures and other contribution disclosures.

The field allows a maximum of 7,500 characters and the included "Font Choice" option lets you select the size and format of the text.

When members view invoices as PDFs in Internet Member Services (IMS), the text from this new field will display at the bottom of the invoice.

New MasterCard Prefixes Now Supported

MasterCard recently announced that they would be adding a new primary account bank identification number (BIN) range of 222100-272099 to be processed in the same manner as the existing bin range of 510000-559999. Per MasterCard, all merchants must support the new 2-series BIN range by January 1, 2017.

Rapattoni *Magic* 10 has been updated to support this new BIN range in addition to the existing BIN range and is in full compliance with MasterCard's updated specifications. With this update, Rapattoni *Magic* 10 and IMS will both accept credit cards beginning with the new 2-series prefix.
